"United Grand Lodge of England was disappointed by the claims published today by former policeman Garry Rogers in advance of his book launch.

On his behalf, and on the behalf of our 200,000 members we have referred his allegations, as printed today, to the IPCC and hope for a thorough and transparent investigation of them.

We always open our membership records when asked by legitimate organisations such as the IPCC to assist them in official investigations.

We note that nobody was named in the article yesterday and trust that Mr Rogers will be as open as we will be in cooperating with the forthcoming investigation.

United Grand Lodge of England has always taken allegations of wrongdoing seriously. Any finding of fact by a court, or a professional body that one of our members has been involved in corrupt practices or dishonest behaviour is dealt with by their immediate expulsion from the organisation. We hope that if no such finding is forthcoming Mr Rogers will apologise to our members, and re-write his book accordingly. Enough is enough."

Further action was taken by writing to both the IOPC (latest incarnation of the IPCC) and to Garry Rogers, asking for the case to be investigated, with which we would fully co-operate.

# 'Masons tried to ruin my career with police'

A FORMER undercover officer presented with the Queen's Police Medal by the Prince of Wales says Freemasons in the force threatened to derail his career.

Garry Rogers claims Masons within Greater Manchester Police (GMP) tried to prevent his bravery being recognised.

He claims he did not receive commendations due to him because officers he believes were Freemasons wrongly suspected him of blowing the whistle on one of their corrupt colleagues.

Mr Rogers - who during six years as an undercover officer helped catch more than 100 violent criminals - says that GMP's most senior officers eventually confirmed that Masons may have tried to block his progress.

Mr Rogers told The Sunday Telegraph: "My original nomination for the

QPM had been shredded by someone within the CID. I believe they were protecting a senior officer who was later arrested, charged and convicted of criminal deceptions. I believe many senior officers were Masons.'

He added: "A report was even placed in my personal file which stated I was not to be trusted and was under investigation, none of which was true."

Mr Rogers's disturbing allegations come after the Police Federation claimed reform of the service was being blocked by Masons, and their influence was thwarting the progress of women and ethnic minority officers.

Dr David Staples, the chief executive of the United Grand Lodge, rejected the claim, saying there was nothing sinister about the activities and rituals of the Masons. He said: "We do not influence the police. We are a non-political, non-religious organisation. The Home Affairs select committee said

there is a lot of unjustified paranoia about Freemasonry."

But Mr Rogers, 60, claims his experience confirms the suspicion that Masons in the police favour fellow members and exert a secretive influence. He said: "I don't think serving police officers should be Masons because it creates a rival allegiance.

During his time as an undercover officer with the GMP's Omega Covert Operations Unit, from 1989 to 1995, Mr Rogers - who is planning to write a book about his experiences - gathered evidence against a killer by joining his gang, broke up an operation by drugrunners by setting up a wine bar to entrap them, disrupted ram raiders and identified more than 50 football hooligans by posing as a skinhead thug.

After taking legal action against GMP Mr Rogers received £8,000 damages for post-traumatic trauma.

In 1999 Mr Rogers, a married father

of three who spent 30 years in the force, finally made the journey to Buckingham Palace to be presented with the QPM.

He says it only came about after a meeting in Nov 1997 with Sir John Stevens, the newly appointed head of Her Majesty's Inspectorate of Police who later became Metropolitan Police Commissioner.

In 2003 - after being given authorised access to his personnel file by a member of GMP's admin staff - Mr Rogers discovered a secret report from 1995, which appeared to explain why it had taken so long for his contribution to fighting crime to be recognised.

It described him as

"paranoid" and not to be trusted and wrongly stated that he was suspected of sending anonymous whistle-blowing letters to GMP and the Manchester Evening News. The letters eventually led to Chief Insp Ken Seddon, the head

of Omega squad, being convicted in 2003 of "multiple offences of dishonesty" involving fraudulent car loans to police officers.

By the time Mr Rogers retired in 2005, he had finally received the support of senior commanders and his allegations appear to have been backed by Vince

Sweeney, the former assistant chief constable of GMP.

In a memo from May 2004, Mr Sweeney described Mr Rogers as "an of-

ficer who has given exemplary service" and who was subject to "some pretty shoddy treatment".

He wrote: "I accepted and find no other explanation than that someone on the then V Command structure effectively halted the progress of that [QPM] recommendation."

Mr\_Rogers subsequently met Michael Todd, who took over as chief constable in 2002, and who he says told him that "what went on was some corrupt Masonic influence within CID" but that "this no longer exists and that most of the concerned left under a cloud".

Chief Constable Martin Jelley, National Police Chiefs' Council lead for ethics and integrity, said: "If convincing evidence ever came to light which clearly showed that Freemasonry was adversely affecting the integrity of the police service then we would take appropriate action."
